Mr. Chiocca and Deputy Chief Eramo discussed the need to complete a contract with the Dispatchers and Animal Control Officer. This is the last remaining contract which has not received a renewal or change as did every other contract in Rockland.

TA Chiocca and Deputy Chief Eramo recommended the BOS follow the same format as was followed with the other unions. The dispatchers and ACO are at the lower end of the pay scale and the recommendation was for a 2 year retroactive contract at 2.5/2.5 which the Police Department will absorb within the current budget.
