31. EXECUTIVE SESSION for negotiations

~MOTION to go into Executive Session for negotiations by Mr. Ryan, 2nd by Mr. Welch passed by Roll Call Vote 4-0.

Chairman Kimball called the meeting to Order.

Police Chief Llewellyn and TA Chiocca reviewed the pending agreements with the Rockland Dispatchers/ACO unit. The contract reflects the financial parameters previously discussed. The contract included minor changes the Chief felt were fair and in the best interest of the Department and employees.

~MOTION to approve the Dispatchers/ACO contract by Mr. Johnson, 2nd by Mr. Ryan passed by Roll Call Vote 4-0.

Police Chief Llewellyn and TA Chiocca reviewed the pending agreements with the Police Superiors Officers Union Local 175. The contract reflects the financial parameters previously discussed by the BOS. The contract included changes the Chief felt were fair and in the best interest of the Department and employees. It was the intention to correct previous disparities in the Superior Officer's pay scale and to create a wider differential between Patrolmen and Superior Officers. There was a feeling the differential was so small that there was little incentive to seek promotion and accept greater responsibility inherent in command positions.

~MOTION to approve the Superior Offices Local 175 contract by Mr. Ryan, 2nd by Mr. Welch passed by Roll Call Vote 4-0.
