31. EXECUTIVE SESSION for negotiations

1. Town Administrator's Contract

The Board first discussed the salary comparisons for Town Administrators and reviewed options with Mr. Chiocca.

TA Chiocca then left the room. Mr. Chiocca's contract expires on June 30, 2016, he is seeking a new 3 year contract.

Attorney Clifford and the BOS discussed the TA's contract. The BOS asked Mr. Chiocca back into the room and discussed compensation. The BOS directed Attorney Clifford to draw up an agreement. The BOS must vote approval for the TA's contract in Open Session.

NOTE: TA Chiocca returned to the room.

2. Police Chief's Contract



NOTE: Mr. Ryan left the room as his wife works at the Fire Department.


3. Fire Chief's Contract
