The BOS reviewed salary comparisons and information from other communities

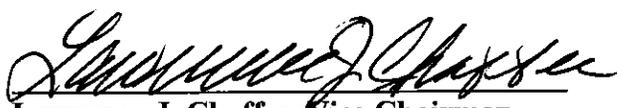
