Present were Mr. Kimball, Mr. Ryan, Mr. Johnson, Mr. Welch, Town Counsel Clifford, and TA Chiocca.

31. EXECUTIVE SESSION for negotiations

MOTION to go into Executive Session for negotiations not to reconvene by Mr. Ryan, 2nd by Mr. Welch passed by Roll Call vote 4-0.

Mr. Kimball called the meeting to order.

1. Police Chief Llewellyn's Contract

Attorney Clifford and TA Chiocca discussed the Police Chief's contract proposal with the BOS. The BOS reviewed the Chief's cover letter and salary comparisons. There was general discussion regarding wages and length of the contract proposal. There was a concern regarding salary commitments for 5 years. The Chief was also seeking a change in insurance language.

A proposal to offer the Chief a 5 year contract with a compensation increase of \$5,000.00 per year, each of the first 3 years, was recommended. The Board would

revisit the compensation issue at that time. The proposal also included the insurance language change the Chief requested.

~MOTION by Mr. Ryan, 2nd by Mr. Johnson to make the above offer passed 4-0.

Attorney Clifford was instructed to draft the agreement the BOS would review at the next meeting.

2. Fire Chief Duffey's Contract

Attorney Clifford and TA Chiocca discussed the Fire Chief's contract proposal with the BOS. The BOS reviewed the Chief's cover letter and salary comparisons. There was general discussion regarding wages of the contract proposal.

A proposal to offer the Chief a 3 year contract with a compensation increase of \$5,000.00 per year was recommended.

~MOTION by Mr. Johnson, 2nd by Mr. Welch to make the above offer passed 3-0.

Attorney Clifford was instructed to draft the agreement the BOS would review at the next meeting.

~MOTION to adjourn by Mr. Johnson, 2nd by Mr. Welch passed 3-0.
