**Mike Feeley** this is a proposed development, here with Gene Guimond and Alan Loomis to represent the Schoolhouse Apartments. We are looking for Planning Board approval of the ANR Plan. **Al Loomis** from McKenzie Engineering stated that this was approved with the ZBA through 40B for 27 units Elderly housing. In order to record upon the sale we need the ANR, the 40B takes care of everything this is just procedural.
