Mrs. Donnelly motioned to approve the minutes from the April 15, 2021, meeting. Mr. Low seconded the motion, and it was unanimously accepted.


Mr. Constantino requested to be on the agenda regarding a high consumption but did not attend the meeting.. Mrs. Donnelly motioned to allow Mr. Constantino one year to pay the high consumption, interest free. Mr. Corvi seconded the motion, and it was unanimously accepted.

The Board reviewed the April 2021 Financial Report. Mrs. Donnelly motioned to accept the Financial Report. Mr. Corvi seconded the motion, and it was unanimously accepted.

Mr. LaPointe presented his Superintendent Report. Mr. LaPointe updated the Board on the Consumer Confidence Report, permanent design for the pipe at the Hingham Street plant, cleaning of the basins, sludge bags, infrastructure funding, Hingham Street plant options, and filter vessel costs.
