ABINGTON & ROCKLAND JOINT BOARD OF WATER COMMISSIONERS MEETING:

The Abington & Rockland Joint Board of Water Commissioners held a meeting on August 24, 2021, at 3:30 p.m. at the Abington & Rockland Joint Water Works Office, 366 Centre Ave, Rockland, MA. Present were the following Commissioners:

Mr. Corvi motioned to approve the minutes from the July 22, 2021, meeting. Mr. Low seconded the motion, and it was unanimously accepted.

The Board recognized Robert Manzella. Mr. LaPointe stated Mr. Manzella was before the Board regarding a water connection he paid for on parcel 54-029 in June 2000, but never tied into the water system. Mrs. Donnelly motioned to approve Mr. Manzella connecting the lot to water. Mr. Corvi seconded the motion, and it was unanimously accepted.

The Board recognized Schoolhouse Apartments. Donna Burks-Smith, Senior Property Manager, represented the Connolly and Partners ownership group and Austin J. Chartier, P.E., McKenzie Engineering Group addressed the Board regarding twenty-seven units at the Holy Family School.

Mike Egan, Commissioner arrived at 3:32 p.m.

Ms. Burks-Smith stated this is a friendly 40B development with affordable senior housing for sixty-two plus years of age. The Board and Mr. LaPointe discussed the water used by the school and the anticipated usage for the apartments. Mrs. Donnelly motioned to approve the project with the following stipulations: twelve months to use the water availability approval, if the project is sold the new owners must come before the Board and it must be sixty-two plus senior housing. Mr. Corvi seconded the motion, and it was unanimously accepted.
